I understand that all members of the wedding party must have their face clean and makeup-free prior to having makeup

applied and if they don't, additional fees may apply.

I understand that all members of the wedding party must be on time.

I understand that if members of the wedding party are not on time, this will make it difficult for the makeup artist to perform all

services on time and effectively.

I understand that the makeup artist will provide clean and sanitized brushes and makeup

#### CONDITIONS OF FEES RECEIVED

I understand that there is a 30% retainer fee to book my wedding day and that is based on the initial estimated invoice of services.

I understand that after retainer payment is received, refunds will not be made for any changes or cancellations.

I understand that I, the Bride, assume all responsibility for payment to the salon for all members of the wedding party.

#### CANCELLATIONS

I understand that any cancellations for individual services made with less than 14 days notice will be charged to the credit card associated with the contract.

I understand that the entire cost of the canceled service(s) will be placed on the credit card without proper notice.

I understand that no refund will be given to members of the wedding party who miss their appointment on the day of the event.

#### LATE ARRIVALS AND EXTRAS

I understand that if my wedding party is more than a half-hour late without making prior contact with the artist, the assumption will be made that the client is a no-show.

I understand that if we are a no-show, I will forfeit all fees

I understand that if my wedding party is late for the scheduled service appointment time the makeup artist may not be able to accommodate the new arrival time.

I understand that if the scope of the original contract cannot be fulfilled due to late arrival, services may be reduced and I will still be liable for the original contracted amount.

I understand that additional fees are required for airbrushing and false eyelash applications.

I understand that it is important that I only use the product(s) that the makeup artist has recommended I use on the day of my event.

I understand that all prices are not exact and subject to adjustments.
